

## **C.-Y. Cynthia Lin Lawell**

C.-Y. Cynthia Lin Lawell is an Associate Professor and the Robert Dyson Sesquicentennial Chair in Environmental, Energy and Resource Economics in the Charles H. Dyson School of Applied Economics and Management at Cornell University.

Professor Lin Lawell's fields of interest are environmental and natural resource economics, energy economics, industrial organization, applied econometrics, and applied microeconomics. Among her current areas of research are the petroleum industry, renewable energy, natural resources, environmental regulation, groundwater, air quality, transportation, agriculture, and development. She uses a variety of economic and econometric methods in her research, including dynamic structural econometric models, structural econometric models of dynamic games, reduced-form econometrics, spatial econometrics, dynamic programming, and optimal control theory.

Professor Lin Lawell has received numerous awards for her research, including the International Society for New Institutional Economics Award for the Best Ph.D. Dissertation; the Harvard University Stone Fellow Award for Best Paper Written by a Doctoral Student in Environmental and Resource Policy; the 2011 University of California at Davis Hellman Fellowship for promising young faculty who exhibit potential for great distinction in their research; and Honorable Mention in the 2015-2016 Bacon Public Lectureship and White Paper Competition. She was a 2017 Cornell University Knowledge Matters Fellow. Her research has also been featured in such media outlets as the New York Times, the Washington Post, the Guardian, Platt's blog, and Bloomberg View.

Professor Lin Lawell is listed among the RePEc Top 5% Economists Based on Publications in Last 10 Years, among the RePEc Top 3% Female Economists Based on Publications in Last 10 Years, and among the RePEc Top 5% Female Economists Based on Publications in All Years.

Professor Lin Lawell is the Director of Cornell University Dynamics, Economics, Econometrics, Policy, and Games: Rigorous Environmental, Energy, Natural Resource, Agriculture, and Development Analysis and Research (DEEP-GREEN-RADAR). She is also the Director of the Cornell University Think-tank for Resources, Energy, and the Environment: Science and Policy-related Economic Analysis and Research (TREESPEAR).

Professor Lin Lawell is the President of the U.S. Association for Energy Economics Bay Area Chapter. She has done consulting work related to renewable energy and to sustainability.

Prior to joining the faculty at Cornell University, Professor Lin Lawell was previously an Associate Professor with a joint appointment in the Agricultural and Resource Economics Department and the Environmental Science and Policy Department at the University of California at Davis. She has served on the California State Controller's Council of Economic Advisors and as the Fossil Fuels Tract Director of the Sustainable Transportation Energy Pathways Program of the UC-Davis Institute of Transportation Studies.

Professor Lin Lawell received her bachelor's degree, *summa cum laude*, in Environmental Science and Public Policy from Harvard College in 2000 and her Ph.D. in Economics from Harvard University in 2006.
